Report any amount that exceeds the per-person gift of \$15,000 on Form 709 and submit it with your annual tax return. Form 709 is due by the filing deadline in the year after you gifted money. If you file an extension for submitting your annual tax return, Form 709 is automatically granted the same extension.

A Deed of Gift is a gratuitous arrangement that voluntarily transfers the legal ownership with physical ownership of a property or money from the owner (called the donor) to another (called the donee) without any consideration or compensation from the donee. A minor (person who is under the age of 18) does not have the legal capacity to grant gift, hence, can not be a donor.
