SOC 1 is an engagement performed under SSAE 16 in which a service auditor reports on controls at a service organization that may be relevant to user entities' internal control over financial reporting. The scope of a SOC 1 report should cover the information systems that are utilized to deliver the services under review.

SOC 1 Requirements for SSAE 18 Reports

Assurance over financial reporting - SOC 1 - reports over controls that impacts the financial reporting of user entities. Typically performed under SSAE16 (issued by AICPA) and ISAE3402 (issued by IAASB) standard. Assurance over non-financial information - ISAE 3000, SOC 2 and SOC 3 - reports on non-financial processing. Factual reporting
